Recent Government Policy Changes

Scientific Committee of the Food Safety Authority of Ireland (FSAI) 2001:

"the precautionary principle should apply and recommends that infant formula should not be re-constituted with fluoridated tap water"

American Dental Association:

children should use water: "purified, distilled, deionized, demineralized, or produced through reverse osmosis."

Health Canada:

"children under age 3 should not use fluoridated toothpaste"

Health Canada:

"Never give fluoridated mouthwash or mouth rinses to children under six years of age, as they may swallow it"

2009 Mandated Fluoridated Toothpaste labels in Canada:

"If more than used for brushing is accidentally swallowed, get medical help or contact a Poison Control Centre right away"

Social Equity = Protecting the Vulnerable

Young children are now being told NOT to use **fluoridated** dental products because they are **TOXIC**.

Babies are now being told NOT to drink **fluoridated water** because it is **TOXIC**.

Municipal Drinking Water should be safe for everyone.

Why add a chemical to drinking water that makes it knowingly unsafe for babies?





Water fluoridation is unlike immunizations - dose of inorganic fluorides is not monitored and controlled.

Water fluoridation is unlike immunizations - inorganic fluorides do not not prevent an infectious disease. (Brailsford et al. 2005 - fluoride does not kill aciduric bacteria which leads to cavities)

Water fluoridation is unlike immunizations - informed consent is not obtained.

Council of Canadians: "It is the Canadian government's responsibility to provide clean, safe, public water for everyone".

Toxic Substances - Hazardous Waste (hydrofluorosilicic acid, arsenic, lead, mercury, radionuclides) are used in municipal artificial water fluoridation.
