Drinking water is a basic human need which has been enshrined as a basic human right by the United Nations.

Public drinking water should not be used to deliver medications.

When fluoride is added to drinking water it deprives citizens of

Section 7: Life, liberty, security of person

Liberty and health security of Canadians is threatened when we are medicated without informed consent. We are medicated without informed consent when drinking water is artificially fluoridated.

Section 15: Equality Rights

Because drinking water is used to deliver this medication, it is impossible to control how much water, therefore fluoride, is consumed each day.

This places unfair burdens, obligations and disadvantages on susceptible minorities who are over-exposed to these products.

Artificial Water Fluoridation Bad Medical Practice

- 1. **UNAPPROVED, UNREGULATED** fluoride products
- 2. **TOXICOLOGY TESTS NOT DONE** to determine safety have not been done
- 3. **NO CONTROL** over who gets the medication
- 4. NO CONTROL over daily intake
- 5. NO INVESTIGATION OF ADVERSE HEALTH EFFECTS by health authorities
- 6. Citizens are deprived of **INFORMED CONSENT**

CHOICE

Council is not allowed to force tested, regulated immunizations on citizens,

Council should not force a fluoride product on citizens which has never been approved or tested for health care purposes.

Doe vs Rumsfield

Court ruled even under emergency conditions of war the Government cannot force an individual to be medicated with a substance which has not been specifically approved for the purpose and manner it is intended.

Paternalism

"interference of a state or an individual with another person, against their will, and justified by a claim that the person interfered with will be better off or protected from harm"

Informed Consent

"Whatever policy is adopted, dental health and any adverse effects of fluoridation should be monitored" and "statistically analysed.

Slippery Slope

What else should we put into drinking water?

Prozac: Anti-depressant drugs? Lipitor: Anti-cholesterol drugs? Ibuprofen: Pain killers? More arsenic and lead from fluorosilicates – not extra charge!?

Ethical Concerns

"The issue of mass medication of an unapproved drug without the expressed informed consent of each individual must also be addressed. The dose of fluoride cannot be controlled....Individuals who are susceptible to fluoride's harmful effects cannot avoid ingesting this drug. This presents a medico-legal and ethical dilemma and sets water fluoridation apart from vaccination as a public health measure where doses and distribution can be controlled."

Citizens are deprived of Informed Choice

- Information regarding risks and benefits
- Choice to refuse or accept
 drug
- Trained professional to assess medical need and adverse effects

"health interventions can only be carried out after free and informed consent"

UK Fluoridation Report Nov 2008

- Alternatives exist which are less intrusive and coercive
- Total exposure of fluoride HAS NOT BEEN EVALUATED
- When "adding unnatural exposures" evidence on safety must be more stringent.
- Public Health Service is **SYSTEMATICALLY IGNORING** the growing body of evidence pointing to risks and inflating the benefits

Ethical Concerns

"In the absence of comprehensive, high-quality evidence with respect to the benefits and risks of water fluoridation, the moral status of advocacy for this practice is, at best, indeterminate, and could perhaps be considered immoral."

Bottled Water

"an uncontrollable dose of fluoride would be given for up to a lifetime, regardless of the risk of caries..."

Is it ethical???

If there is no known "safe" dose for the contaminants found in trace amounts in the fluorosilicates (arsenic, lead, mercury, radionuclides)...

Is it a good idea to add these to our drinking water?

Can we be sure that these contaminants, consumed daily, for a lifetime, cause no harm?
